ARDITO tools for textual publishing

ARDITO is developing new applications to:

- use watermarks to access rights and licensing directly and to identify re-use options for e-books→ lcontact
- assign DOI-based identifiers (called ARDI) to Digital Rightsholder Statements to declare rights on content (ex author-publishers)→ mEDRA



- DOI = multi-purpose, multi-content, persistent web resolvable ID
 - Approx. 150 million DOIs assigned across media and content types
 - DOI resolution can be Single, Multiple and Context-aware
 - DOI + ISBN = ISBN-A
 - ISO standard
- How it works: when used in the Internet, the DOI works like a link redirecting the user to a resource. Examples:
 - 10.3233/JAD-2010-101674→https://doi.org/10.3233/JAD-2010-101674
 - 10.978.8899630/096 → https://doi.org/10.978.8899630/096



- Our work in ARDITO exploits DOI features to connect content and rights
 - Extensible metadata framework
 - We use the DOI to identify rights declarations (ARDI)
 - We can connect rights data to content
 - Scalable to any type of content assets
 - Resolvable identifier
 - Enhanced discoverability of rights declarations and rights information
 - Access rights declarations and rights information from the content ID (Rights-aware resolution)
 - Standard and interoperable identifier
 - We can easily connect with the Copyright Hub as extra access point to tools and services
 - We can connect to other ARDITO tools and services



ARDITO tools

- ARDI service: tool to enable registration of Digital Rightsholder Statements (DRS) and issuing of ARDI identifiers
- Rights-aware DOI suite:
 - interfaces to create rights-aware DOIs
 - automatic service to create and use ISBNs as DOI-based web resolvable IDs (ISBN-As)
 - customisable interfaces for rights-aware resolution to be used at the point of discovery of the content on the web or in machine to machine manner




The ARDI service

- Deposit a DRS
- Assign an ARDI identifier (DOI-based)
- Service interactions:
 - Register ARDI resolution (Handle System)
 - Persist DRS and ARDI metadata (mEDRA ARDI System)
 - Onboard in the Copyright Hub (Hub Repository System)
- Activate rights-aware resolution on the content DOI
- Access the DRS
 - Through ARDI resolution
 - Through rights-aware resolution of the content DOI
 - Through Copyright Hub plug in
 - Through watermarking decoding (see BooXtream presentation)







From tools to services

- The ARDITO tools will be integrated into mEDRA DOI Registration Agency platform and used to:
 - create a new service for customers to register rights-aware
 DOIs, or add rights-awareness to existing DOIs
 - expose and make available for reuse information about rights and licenses in a range of different methods and formats
- The ARDITO tools will be integrated into Italian ISBN agency platform and used to:
 - create a new service for author-publishers to declare their rights when they request an ISBN
 - have the above declaration linked to the content anywhere in the web, through the same ISBN empowered by the DOI features (ISBN-A plus)
